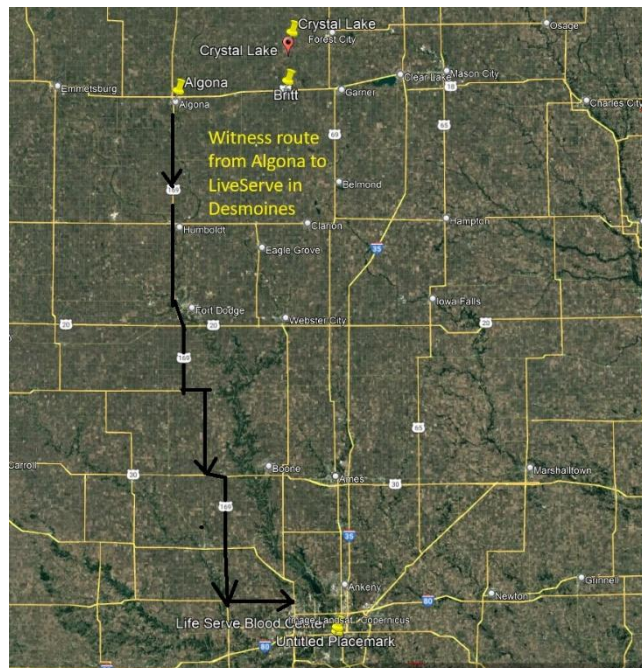


Algona, Iowa to Des Moines, Iowa—March 28th, 2024—MUFON Case # 141236

An Ankeny, Iowa witness left the Algona hospital at about 2:00 a.m. on March 28th, 2024 on his way to the Life Serve Blood Center In Des Moines, Iowa to make a blood delivery, a two-hour trip he had taken many times over the past three years. The Life Serve Blood Center tests blood samples and distributes blood to where it is needed.

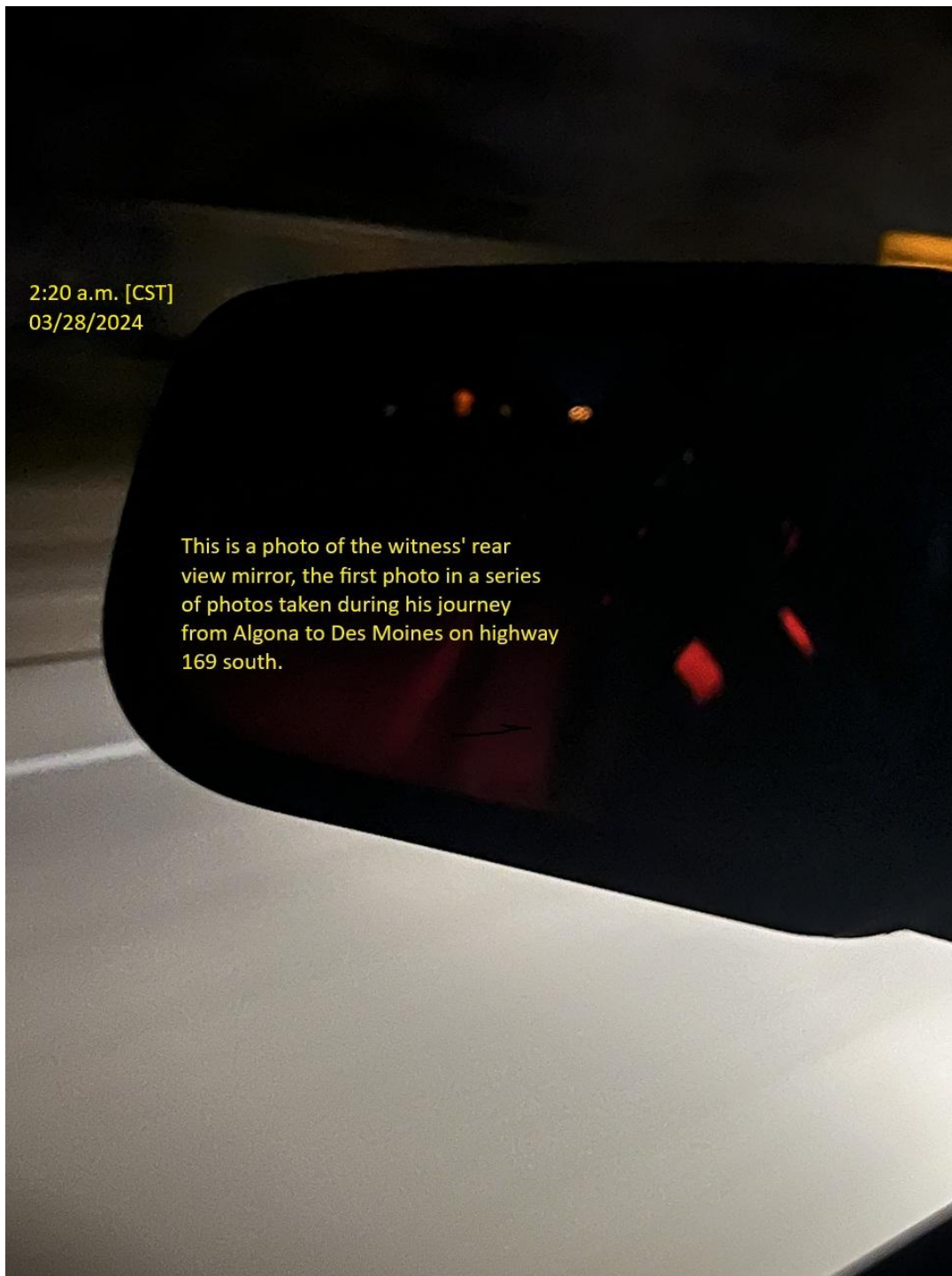


Witness's route from Algona to Des Moines

His sister, Sheila, who works for the same company and was driving in her car near Waterloo was also doing a blood delivery. She was on the phone with her brother during his entire trip.

During his harrowing journey on highway 169 from Algona to Des Moines he took approximately fifty photos, sending them to his sister in real time.

Below is a photo he took of his rear-view mirror, the first of many photos he took during his journey.



When his sister saw this photo, she believed that she saw a face in the mirror and told him to get out of there as fast as he could. See photo below.



As he continued his journey, he experienced all kinds of bizarre activity including as many as fifty orbs of light that fell from the sky on both sides of the road and in the fields; behind him he observed a huge white square object.

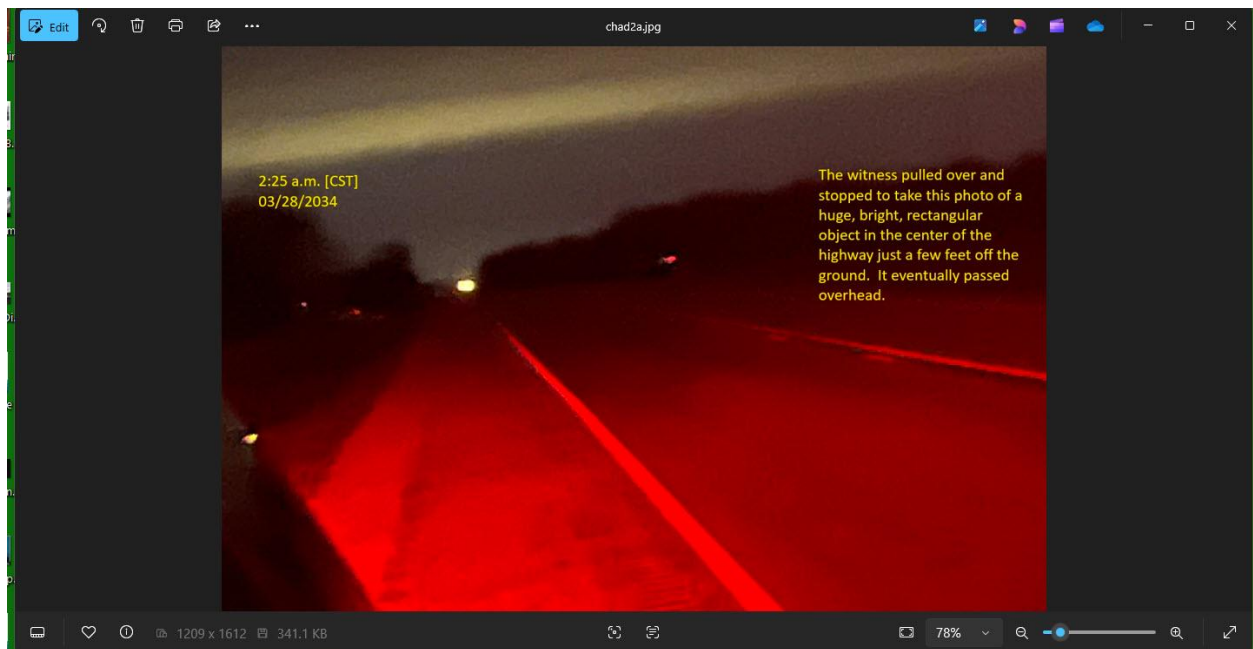


Magnified photo of the huge, bright, rectangular object behind him in the center of highway 169

He decided to pull over and stop to take photos, of the orbs that fell from the sky. He said, “I stopped and took this picture and you can see they [the orbs] turned into some type of shape, animal, maybe a human type figure, but crouched down into like a running sprint.”

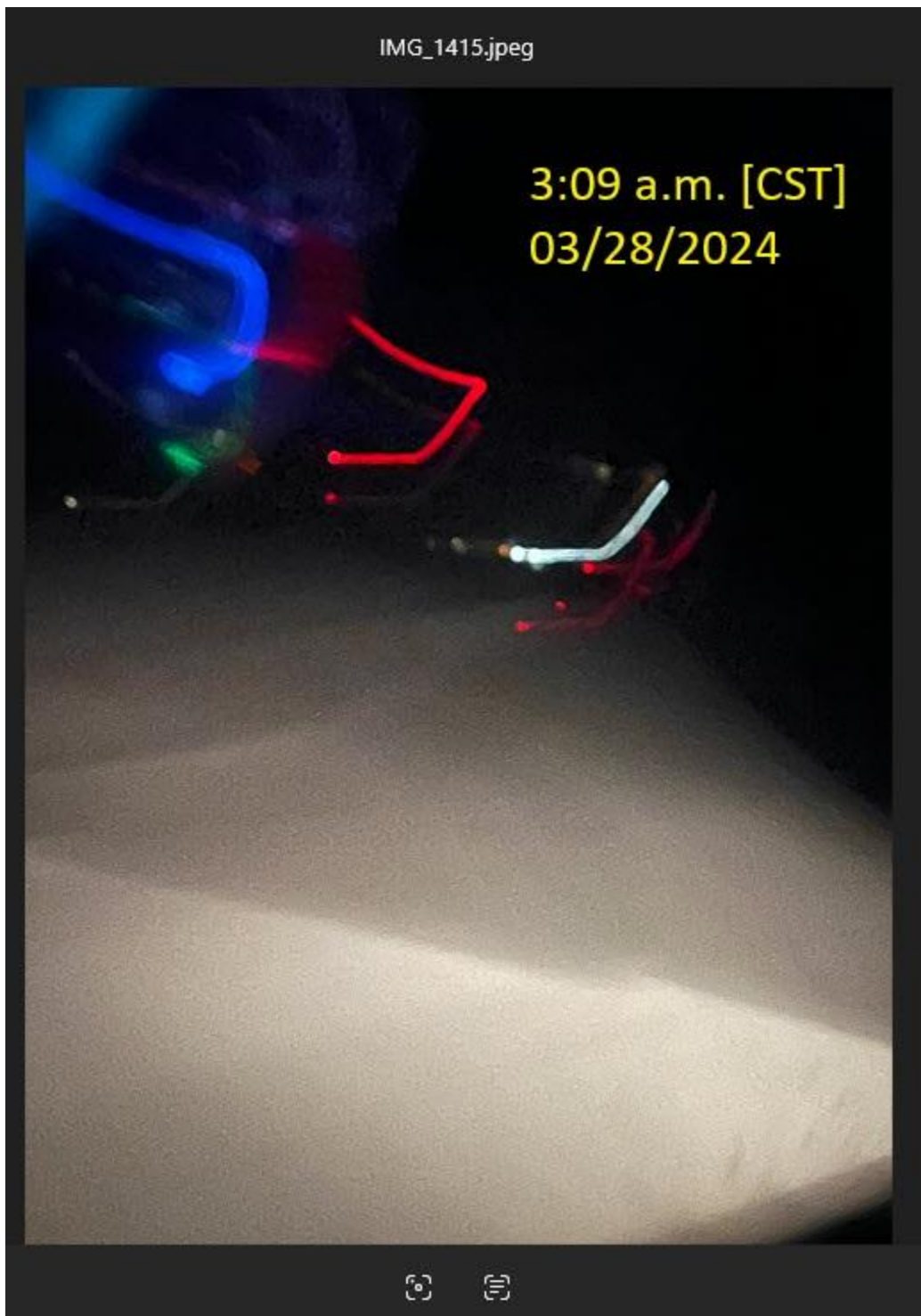


The witness got back into his car and continued his journey and the chase began, as the entities followed close behind. In a futile attempt to outrun the orbs, he accelerated off at high speeds but the entities kept pace and began slamming into his car. He felt that they were trying to push him off the road. He stated, “The one on the right [the small orb to the right of the rectangular object] took off and met my speed after I drove off fast and hit speeds at 120 mph in my Equinox, and it slammed into my vehicle on the driver side and was in my back seat.”



His sister, who was on the phone, said that she could hear the thumping of the objects hitting his car and the sound of him hitting the rumble strips on the side of the road. His speakers began to distort and his sister could hear the humming sound through the phone.

I sent the photos taken during the witness' trip to both the Iowa State Director Greg Andersen and Seth Feinstein for further photo analysis.

In summary Mr. Feinstein said, "The meta data verifies the date and location. The witness' work and background would tend to lead one to believe he is a reliable witness. The event is confirmed by his sister on the telephone."

He further states: ... "I think the witness has evidence in the street image which along with his sister's testimony support his story...The rolling shutter camera artifact is prominent in this image... photo forensics show what could be evidence of ant-like and large cranium species of alien figures on top of the jagged lights in the image..."

The primary witness in this case is 53 years of age and has raised four daughters. He has been a composite engineer, has been to Turkey, Juarez, Mexico for work, lived in Florida, and worked for Disney and universal studios for a sub company. He says that he doesn't do drugs, and he is mentally sound.
